Vice-Chairman M. Fernandez called the meeting to order at 8:53 a.m. with a quorum being present.

ADMINISTRATIVE ISSUES

Board Attorney, R. Klausner reported that an Order granting the City's Emergency Motion for Injunction had been received. Attorney Klausner informed the Board that he was working with the City on a Stand Still Agreement that would allow FIPO to continue to disburse the restored benefit payments. Discussion ensued. Vice-Chair M. Fernandez recapped actions taken by the Board at their June 10th meeting directing the Administrator to revert back to the December, 2017, benefits if an Injunction was received. Discussion resumed. Assistant City Attorney, K. Jones, was present and he was asked by Trustee T. Roell if he could corroborate that the City was working on a Stand Still Agreement. K. Jones stated that he was not present at the meeting and would reframe from responding. Discussion continued. Administrator asked if the benefits needed to be reverted for the August payroll. The Attorney suggested September in order to provide affected members with notification of the change. Vice-Chair M. Fernandez asked for an update on the notification letters that the Board asked be sent to the members. Attorney Klausner explained that based on dialogs taking place with the City, he had used discretion and delayed sending out any notification. Discussion resumed. A motion was made by O. Cotera and

seconded by T. Roell letters be prepared for distribution based on the outcome of the meeting scheduled with the City on August 10, 2018. The motion was approved by a vote of 5 to 1 (dissenting M. Fernandez). O. Cotera moved and was seconded by T. Roell to direct the Administrator to revert benefit payments back to the December payroll if a Stand Still Agreement was not executed by August 9, 2018. The motion was approved unanimously.

Attorney Klausner was asked that he keep the Board updated on the issue on a regular basis.

INVESTMENT /ISSUES AND PERFORMANCE REVIEW QE 06/30/2018

MILLIMAN USA - Represented by W. Cottle, S. Cottle

The Consultant reviewed with the Board the performance for quarter ending June 30, 2018. Specific points addressed are as follows:

Performance Report

The FIPO Trust had a total market value of \$1,557,226,666.00 as of June 30, 2018, which represents a decrease of \$11.5 million from the March 31, 2018 market value of \$1,568,835,818.00. The overall decrease in the Trust's market value was the result of \$36.4 million in net cash flows and an investment gain of \$24.9 million. The Trust had a return of 1.5% during the second quarter of 2018, which outperformed the Fund's benchmark of 1.4%.

Watch List

First Eagle's value-oriented international equity portfolio was placed on the Watch List at the November 2, 2017, Board Meeting. There was improved performance in the past quarter, but the one year results are still well below their benchmark. First Eagle will remain on the Watch List.

Investment Policy

The Consultant reviewed with the Board proposed changes to the Investment Policy. A question and period followed the review. A motion was made by T. Roell and seconded by N. Enriquez to accept the changes. The motion was approved unanimously. The Consultant once again asked the Board allow further review on Emerging Markets. The Board directed the Consultant to prepare report to be presented at the November meeting.

MANAGER PRESENTATIONS
